

Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

CHOICE OF LAW: I understand and agree that the law of the State of Nebraska will apply to this contract.

- Games are played to 21 or whoever is ahead at the end of the 15-minute time limit. If one or more bags have been thrown at the 15-minute mark then all of the bags will be thrown for that round.
- There will be 8 pools with 4 teams per pool. Each team will play the other 3 teams in their pool. The top two teams in each pool will go into a single elimination tournament. The final 4 teams will win \$\$\$. 100% of the entry money will be paid out. The winner will receive an NLD Cowboy Cornhole Trophy in addition to \$\$.
